Cover: Bill & Mike Blackburn - Father/Son Corvettes

My father, Bill Blackburn, and I have shared an interest in cars my entire life. I come by this interest honestly as my dad used to drag race and attend car shows in Ohio where we both are from. In 1955, Dad and his buddies went to the World Auto Show at the Indianapolis 500 Speedway where they entered a Model A coupe, a car that was later featured in Hot Rod Magazine. Then in 1957, my dad became a member of the prestigious "100 MPH Club" in Cincinnati, Ohio when he raced the quarter mile at 107 MPH in 11 seconds driving a Ford Model A sedan. That car was built as a drag racer and was painted to read "Hated" on the back. If you looked closely below the name Hated, the small print read "by our wives."

Years later when I got into high school I saved virtually every dollar I earned in order to purchase a car. Dad and I searched high and low and finally found a nice 1968 Pontiac LeMans, red with a black vinyl top, that we turned into a hot rod. Those were special years we shared!

In the many years since, I've had a number of high-performance cars, but I'd never owned a Corvette. Then in December 2012 I announced my retirement after 34 years in police work. The first thing I did was consult with friends Scott White and Ken Jones, members of the Corvette Marque Club of Seattle, in order to find a suitable "retirement gift" for myself. With their direction and advice I located a 2003 C5 Anniversary Edition convertible and joined CMCS.

Later that same year, I took Dad out to meet my friend, Joe Harvey, at Speedway Chevrolet. It was there that dad purchased a black 2004 C5 Corvette convertible and joined me in CMCS. Dad and I have been showing and driving our Corvettes together ever since. We enjoy the various CMCS parades, luncheons and dinners, but we really have fun at the car shows.

Shortly after Dad purchased his 2004 convertible, Joe Harvey had me look at a Magnetic Red 2005 Z51 Coupe he located in California. The car was exceptionally nice with a number of performance upgrades. It was also in mint condition and therefore too good to pass up.

However, with my change of vehicles, Dad found himself back out visiting with Joe Harvey. Joe got Dad into a beautiful C6 convertible that had been a first place winner in a recent Northwest Association of Corvette Clubs show. Once again, Dad and I were owners of similar and remarkable cars, so we jumped right back into the local car show scene.

In October 2014, with the success of the new Corvette Stingray well established, I've upgraded yet again to a brand new Torch Red Z51 coupe with all the performance upgrades including magnetic ride and the Performance Data/Video Recording system. Given the Corvette history Dad and I share, I think it's about time for him to go back out to visit Joe Harvey.




Funny Foto Classic - Santa's New Sleigh

Laps from the Past

November Laps

50 LAPS AGO: November '64. The Club monthly meeting was called to order by President Dick Stanley at the AAA Building. The Treasurer announced the Club's finances were in the black, and, guests attending the meeting were introduced. Chuck Sienkiewick described the coming CMCS Inclement Rallye. Club badges, jacket patches, and jackets were on hand for purchases. There was an amendment to the CMCS By-laws

presented to the membership, voted upon and passed pertaining to Article I, Section II, Sub section 4, to read: "Sponsorship by two members of the corporation in good standing and attendance of one meeting of Club activity prior to nomination." An economy run will be presented in January by Sue Stanley and Bob Morse. The Club passed a second motion to join the Northwest Rally Council. Dick Stanley was appointed to represent the Club. Bob Morse reported on his progress to organize all the yearly activities of all the sports car clubs in the northwest. Ron White and Bob Morse planned to attend the first meeting at which each sports car club was to send representatives. It was agreed to inform Mike Campbell of our suggestions for improving the methods used for next year. National Corvette Museum News

Skydome History

In looking through Museum Grand Opening press releases we ran across details about the iconic Skydome. Did You Know...

"We were determined to build something as innovative and dramatic as the Corvette itself," said Ken Neumann, FAIA, design principal at Neumann Smith & Associates. The National Corvette Museum's signature yellow and red, 11-story cone and light tower (the tallest structure on I-65 between Nashville and Louisville at the time) stands in tribute to the architect's understanding of the Corvettes' magic. "It looks just like the tail light assembly turned on its side," continued Neumann.



2009 ZR1 Blue Devil Makes Debut After Restoration

Last month at the SEMA Show in Las Vegas, Chevrolet held a surprise unveiling - the restored 2009 ZR1 Blue Devil, which had fallen victim to the Museum's sinkhole in February.

The car had been on display at the Museum as-is from March 3, when it was recovered from the hole, through August when it was returned to Chevrolet for restoration. Damage included: cracked carbon-fiber ground effects and a broken passenger-side rocker panel; damaged passenger front fender as well as cracks in both doors; cracked windshield, hood window glass and passenger headlamp assembly; bent



rear control arms on the driver's side door; and cracked oil lines to the supercharged LS9 engine's dry-sump oiling system.

Six weeks after work began, the restored ZR1 was started for the first time at the GM Heritage Center.

Construction, Start Your Engines!

Construction is underway in our Skydome to repair the sinkhole and get that portion of the Museum back up and running. On Monday, the remaining six "Sinkhole Corvettes" were moved from the Skydome. The 1.5 Millionth Corvette is currently in the turntable in the lobby, the Spyder is viewable from the Enthusiast area, and Ruby and the 1962 are on a lift in the garage bay in the Engineering area.

Last month, we welcomed home the 2009 ZR1 "Blue Devil" in its 'good as new' condition. The car was repaired courtesy of General Motors, and made its debut the previous week at SEMA.

All web and security cameras in the Skydome have been disconnected. In order to facilitate the construction work that will be done in the Skydome, the inner ring of lights had to be raised up as high as they could get it. Unfortunately the cables that ran to all of our web and security cameras were tied into this inner ring of lights. Each one had to be disconnected from the main router switch, so that the inner ring could be raised



up out of the way. While we will not be able to provide live web streams from the Skydome, we will continue to share updates via our eNews and on social media. Thank you for understanding!
